Course unit objective

To familiarize students with the tourism related concepts, categories, institutes, operators, general and specific requirements for conducting business, as well as to make them familiar with the legal relations between: holders of tourist activities (tourism service providers and travel agencies) for the purpose of the conclusion and performance of some of the typical tourist contracts (allotment contract or agency contract for hospitality services); holders of tourist activities and a third person when they conclude a contract that is associated with the provision of tourism services (contract of carriage or insurance contract); holders of tourist activities and service users which is the final relation and *conditio sine qua non* in order for tourist service to be realized.

Learning outcomes of Course unit

Students are expected to acquire knowledge about the legal aspects of tourism related business, including legal status of tourism entities and typical tourist contracts (package travel contract, intermediary travel contract, allotment contract, hospitality services contract, agency contract for hospitality services, food and drink services contract, timeshare contract) in order to develop capacity and skills for both practical and theoretical work in the field of hospitality and tourism.

- Legal form and status of holders of tourist and hospitality activities
- Types of holders of tourist and hospitality activities

- Intermediary travel contract
- Allotment contract
- Hospitality services contract
- The agency contract for hospitality services
- Food and drink serving contract
- Timeshare contract

Practical classes

Practical work with students will be focused on the legal analysis of the provisions contained in tourism related laws, comparison of travel and tourism rules contained in Serbian law with the respective rules at the EU level, case law. As part of the practical classes, students will take two tests and prepare term papers (both individual and team work is allowed).
